

WEBSITE PRIVACY AND COOKIES POLICY

The following statement explains our policy regarding the personal information we collect about you.

1. Introduction

- 1.1 This policy covers Together's use of personal information that Together collects when you use www.togethertv.com
- 1.2 Together is owned by The Community Channel, a charitable Community Benefit Society registered with the FCA (RS007400) and HMRC (EW58536)
- 1.3 From time to time, you will be asked to submit personal information about yourself (e.g. name and email address) in order to contact Together.
- 1.4 By entering your details in the fields requested, you enable Together to provide you with information you require. Whenever you provide such personal information, we will treat that information in accordance with this policy.
- 1.5 When using your personal information Together will act in accordance with current legislation and aim to meet current Internet best practice
- 1.6 If you provide the email address of a third party to Together, we understand that you have permission to use this email address
- 1.7 This web site does not automatically capture or store personal information, other than logging the user's IP address and session information such as the duration of the visit and the type of browser used. This is recognised by the web server and is only used for system administration and to provide statistics, which Together compiles to evaluate site use. Please see our cookie policy below.

- 2. Use and storage of your personal information
- 2.1 When you supply any personal information to <u>www.togethertv.com</u> we have legal obligations towards you in the way we use this data.
- 2.2 We must collect the information fairly, that is, we must explain how we will use it and tell you if we want to pass the information on to anyone else.
- 2.3 In general, any information you provide to Together will only be used within Together and the software and platforms it uses for communications
- 2.4 Your information will be disclosed where we are obliged or permitted by law.
- 2.5 Also, if you post or send offensive, inappropriate or objectionable content anywhere on or to <u>www.togethertv.com</u> or otherwise engage in any disruptive behaviour on <u>www.togethertv.com</u>, Together can use whatever information that is available to it about you to stop such behaviour.
- 2.6 This may involve informing relevant third parties such as your employer, e-mail/Internet provider and law enforcement agencies about the content.
- 2.7 We will hold your personal information on our systems for as long as you use the service you have requested. We will ensure that all personal information supplied is held securely, in accordance with the Data Protection Act 1998.

- 2.8 We will not contact you for promotional purposes, such as notifying you of improvements to the service or new services on <u>www.togethertv.com</u> unless you specifically agree to be contacted for such purposes at the time you submit your information on the site, or at a later time if you sign up specifically to receive such promotional services.
- 2.9 The Lawful Basis for holding your data is Consent, namely if you submit your personal data, including name and email address, when you sign up to our newsletters or submit comments on the website.
- 2.10 The GDPR definition for Consent is "any freely given, specific, informed and unambiguous indication of the data subject's wishes by which he or she, by a statement or by a clear affirmative action, signifies agreement to the processing of personal data relating to him or her."
- 2.11 Access to your personal data will be restricted to relevant employees only.
- 2.12 This data will be held on cloud-based software services (e.g. MS Exchange for Outlook emails, Box document storage), some of which will be hosted on servers outside the EEA.
- 2.13 Appropriate safeguards have been implemented which protect your rights in accordance with current data protection laws

If you did wish to access your data, you shall have the right to view or receive a copy of the information in a commonly used format such as a pdf document or an e-mail. Any information which is processed by automated means and is purely required for the performance of a contract, may be transmitted to another data controller if you request it.
- 3.3 You may also have the right to ask for the processing of your personal data to be restricted or even erased. Whether or not you exercise the right to erasure, the Company will erase your personal data in certain situations and particularly when the data is no longer required.

6. How Cookies are used by Together

6.1 Cookies cannot be used to identify you personally. These pieces of

information are used to improve services for you through, for example:

- enabling a service to recognise your device so you don't have to give the same information several times during one task
- recognising that you may already have given a username and password so you don't need to do it for every web page requested
- measuring how many people are using services, so they can be made easier to use and there's enough capacity to ensure they are fast
- analysing data to help us understand how you use our services so we can improve them
- 6.2 Cookies are stored in the computer's memory only during your browsing session and are automatically deleted from your computer when the browser is closed.
- 6.3 These cookies usually store a session ID that is not personally identifiable to users, allowing you to move from page to page without having to log-in repeatedly.
- 6.4 Session cookies are never written on the hard drive and they do not collect any information from your computer. Session cookies expire at the end of your browser session and become no longer accessible after the session has been inactive for a specified length of time, usually 20 minutes.

7. Our use of third-party Cookies

- 7.1 We use Google Analytics to collect anonymous information about users' activity on the site, for example the number of users viewing pages on the site, to monitor and report on the effectiveness of the site and help us improve it.
- 7.2 The User and Event Data Retention within Google Analytics is set to 'Do Not Automatically Expire'. Google Analytics data will be stored indefinitely, subject to acceptance and interaction of Google Analytics cookies. No personal information is held.

- 7.5 Google may also transfer this information to third parties where required to do so by law, or where such third parties process the information on Google's behalf. Google will not associate your IP address with any other data held by Google. You may refuse the use of cookies by selecting the appropriate settings on your browser. However, please note that if you do this you may not be able to use the full functionality of this website

8. How to opt out of cookies

- 8.1 Our website works better with cookies enabled. Our cookies don't give us or anyone else access to your personal data. We advise you to keep cookies enabled. However, you can choose to reject cookies.
- 8.2 You can use your browser to delete and reject cookies. There are instructions on how to delete cookies and how to control cookies on the 'About Cookies' website.
